Dear Supervisor Heffner and Mr. Schwartz:

I write to oppose the proposal by Seneca Resources Corporation to hydraulically fracture 8 new oil and gas wells and lay 8,000 feet of new pipeline in the beautiful Sespe backcountry.

Having grown up in Ojai, many of my fondest childhood memories involve hiking and camping in the Sespe. Starting when I was 7, I traversed the Sespe trails countless times, exploring the mammoth boulders of Piedra Blanca, hiking from Fillmore to Rose Valley and back, marveling at meteor showers while cocooned in a sleeping bag, spotting horned toads and condors, easing into the scalding waters of Willett Hot Springs, diving through thin layers of ice atop deep, blue winter water holes, and finding refreshment at each stream crossing. As such, this issue is deeply personal to me.

I oppose Seneca's proposal because of well-documented concerns about contamination, pollution, greenhouse gas emissions, increased seismic activity, and water depletion. I am not alone in my view: the local community vehemently and vocally opposes fracking in the Sespe.

This is demonstrated by the nearly 1,700 signatures on the **attached petition** that I collected over the last two weeks with no budget or organizational-backing. As you can see, the vast majority of these signatures and comments are from concerned, local residents, while the remainder are from people concerned about fracking on our shared federal land.

I was moved and inspired not just by the quantity of signatures we collected, but also by the personal stories people shared about the Sespe. There was the Chumash woman who described the significance of the Sespe to her tribe, and revealed that the area was one of the last known habitats for grizzly bears in California. Or the Oregon man whose wife grew up hiking in the Sespe and who desperately wants to experience the trails and streams with her before the area's natural beauty is compromised. Or the local farm manager concerned, like many members of the agricultural community (including my own farming family in Ojai), about the impact of water-intensive fracking on already-low water reserves.

These stories reaffirmed my commitment to putting an end to fracking in the Sespe. But they also reaffirmed my fundamental belief that, in a democracy, citizens have a responsibility to come together and make our voices heard, just as our government officials—as representatives of the People—have a responsibility to listen and carefully consider those views.

Therefore, it is my sincere hope that this mass expression of community opposition to the proposed fracking will cause the Forest Service to reconsider the merits of fracking in the Sespe and to deny Seneca's proposal to frack 8 new wells. At the very least, the Forest Service should undertake a full environmental impact study to determine the safety of fracking and the long-term consequences to our air and watershed before issuing any new permits.

Contrary to the oil industry's assertions, petitions like mine are not simply "much ado about nothing." There have been countless horror stories around the country about pollution and water contamination from fracking. In 2008, two families in Pennsylvania reported contamination of their well water after Seneca fracked a nearby well. Their contaminated water gave off strong fumes and burned their mouths and lungs when consumed. Seneca was forced to drill a new well for the family. And just this year, a jury in Texas (hardly a bastion of environmental activism) awarded a family nearly \$3 million after their air and drinking water were contaminated by fracking operations, causing their young daughter to experience nose bleeds and rashes. I, for one, do not want to take that chance here.

Therefore, I urge the Forest Service to deny Seneca's proposal to frack 8 new wells in the Sespe. Please feel free to contact me should you wish to discuss this matter further. I can be reached at Leif.Dautch@gmail.com or (203) 668-1617.

Dear Supervisor Heffner and Mr. Schwartz,

We oppose Seneca Resources Corporation's request to frack 8 new oil and gas wells in and around the Sespe wilderness. Given the potential dangers of fracking for our drinking water, air, climate, and communities, we don't want the Sespe to become the epicenter of fracking on the Central Coast.

Communities around the country have seen their water and air contaminated by fracking, and we don't want ours to be one of them. Cement in the wells can crack and leak under the high pressure at great depths, releasing toxins into our drinking water and the powerful greenhouse gas methane into the atmosphere.

Until fracking is conclusively proven not to pose these dangers, we oppose all new fracking operations in and around the Sespe. Now is not the time to double-down on a perilous bet that poses grave threats to our environment and our communities. Let's wait until regulators, scientists, and industry officials can study the potential impacts of fracking, so we can at least make an educated and informed decision.

In the meantime, please don't authorize new fracking operations in the Sespe. Preserve our pristine wilderness and protect our watershed from contamination and depletion!
