



Three Links Creek was preliminarily deemed unsuitable for Wild and Scenic designation in 1995. This was not a good decision and should be revisited. Three Links is a great whitewater run, a beautiful hike, and on May 2, 2009 we watched a massive steelhead leaping a drop that was located over two miles and 600 vertical feet upstream of the confluence with the Selway. Three Links also has an enormous log jam (pictured) and runs clear even at high water, both indicators of a high energy healthy stream. Three Links is the only whitewater stream that enters the Selway that can't be accessed upstream (Like Bear, Moose, and Meadow). Three Links is a special stream and should be found eligible for Wild and Scenic designation. Suitability determinations are not justified at this time.



A 1995 preliminary assessment found the Moose Creek, its East, North, and West Forks, and Rhoda Creek to be unsuitable for Wild and Scenic designation. This conclusion is unsupportable. The Moose Creek Complex is one of the most remote and intact river systems in the region. Each of the aforementioned streams are spectacular whitewater runs that offer a level of inaccessibility virtually unheard of in the lower 48. Their unique recreational values alone should render them eligible for W&S designation. Their fisheries value, especially as spawning and rearing habitat for anadromous species (upon their recovery) is also outstanding. These streams should be found eligible.

The Great Burn is a vital biological core area for far-ranging wildlife in the northern Rockies. The Great Burn serves as a biological bridge, permitting migration and genetic interchange… without which populations will inbreed and species vigor will diminish. Throughout the year, mountain goats inhabit high rocky terrain, including the high cirque basins in the stateline area. Studies indicate they are particularly sensitive to activity above them. Snowmobile or bicycle activity on the Stateline ridge above occupied mountain goat habitat may displace and threaten mountain goats during particularly vulnerable periods of late winter and spring. Similar evidence reports that such activities in high elevation cirque basins near the Stateline Trail may affect denning wolverines as well. As a result, I urge you to retain closures to both mechanized and motorized uses in the Great Burn area and to recommend the entire area as Recommended Wilderness.

I've seen a dramatic drop in mountaingoat populations in these areas since the late 1990's. We've backpaked here annually since ther 1973, and typically counted up to 100 goats throughout the 70's, 80's and early 90's. The proliferation of more powerful, longer-range, noisy snowmobiles has decimated the numbers of these timid, reclusive animals since the late 90's. The goats are particularly noise sensitive, causing them disruption and displacement; at a time of year when they are already weakened and vulnerable due to cold, harsh winter conditions. One study showed that snowmobile noise affects goats up to 3 miles on each side of the travel corridor. PLEASE designate Williams peak, Rhodes peak, cache saddle, blacklead mtn, crooked fork, shale mountain, and a surrounding buffer area off-limits to snowmobile use for the sake of mountaingoat populations.

The Great Burn serves as a biological bridge, permitting migration and genetic interchange…without which populations will inbreed and species vigor will diminish. Throughout the year, mountain goats inhabit high rocky terrain, including the high cirque basins in the stateline area. Studies indicate they are particularly sensitive to activity above them. Snowmobile or bicycle activity on the Stateline ridge above occupied mountain goat habitat may displace and threaten mountain goats during particularly vulnerable periods of late winter and spring. Similar evidence reports that such activities in high elevation cirque basins near the Stateline Trail may affect denning wolverines as well. As a result, I urge you to retain closures to both mechanized and motorized uses in the Great Burn area and to recommend the entire area as Recommended Wilderness.

The Great Burn serves as a biological bridge, permitting migration and genetic interchange… without which populations will inbreed and species vigor will diminish. Throughout the year, mountain goats inhabit high rocky terrain, including the high cirque basins in the stateline area. Studies indicate they are particularly sensitive to activity above them. Snowmobile or bicycle activity on the Stateline ridge above occupied mountain goat habitat may displace and threaten mountain goats during particularly vulnerable periods of late winter and spring. Similar evidence reports that such activities in high elevation cirque basins near the Stateline Trail may affect denning wolverines as well. I access the Great Burn via HooDoo Pass, Schley Mountain Road and Lolo Pass/Lochsa area in both backpack and snowmobile season. I never see more than squirrel tracks in the winter through June during snowmobile season. Snowmobiles are making minimal impact on the wildlife or environment during their season. Snowmobile or bicycle activity on the Stateline ridge above occupied mountain goat habitat may displace and threaten mountain goats during particularly vulnerable periods of late winter and spring. I backpack in the great burn area each year. This area should be better protected. I recommend closing the trail to Fish lake to all vehicles. Near fish lake the hill sides and meadows contain scars (ruts) from vehicles that leave the access trail. In addition, the noise from these vehicles, racing up and down the trails spoils the wilderness experience. Close this trail to vehicles






