For more than 75 years, the Idaho Farm Bureau has been recognized as the leading advocate for private property rights and prosperity which comes through the wise use of and responsible stewardship of our natural resources. We thank the Forest Service for this opportunity.

Our interest in the SGP revolves around the use of these natural resources found in our National Forests. New wealth comes from the ground, and as it is wisely used and managed our nation and communities will continue to prosper. Farm Bureau Policy supports the continuation of mineral extraction in Idaho as long as the appropriate mine reclamation and environmental protections is in place and followed.


The SGP, as proposed by Midas Gold, appears to have the good of the environment in mind. The company's proposals to relocate and reuse spent ore, process and store old tailing piles, restore stream channels and fish passage, reestablish the function of wetlands, replant areas burned by wildfires, amongst several other projects, would greatly improve the current situation and environmental issues that this site currently faces.
