**Re: Stibnite Gold Plan of Operations EIS #50516**

Please accept our unique comments on the **Stibnite Gold EIS** in the Payette National Forest. This project is a unique opportunity for environmental restoration and responsible economic growth.

Rarely does the US Forest Service (USFS) have an opportunity to accept a project like Stibnite into its public lands portfolio. This project will undertake the restoration of legacy environmental damages from nearly 100 years of mining activity, much of which was created to meet the critical needs demanded by the United States Federal Government during wartime. The creation of new fish passages, streams, and reforestation will all be undertaken by the project proponent at no obligation to the taxpayer. Without these efforts these legacy issues will go unresolved. Simply put, the cost of no action is too high of a price for the environment on our public lands.

Furthermore, Valley County, Idaho is one of the more economically challenged locales in the western US. The impact of tax revenue estimated to be \$329 Million in federal corporate income taxes and \$86 Million in State corporate income and mine license taxes is an enormous impact. These good paying, safe and stable jobs are not a temporary impact. They are life changing moments that will last generations in the rural area.

AEMA has long been an advocate for lessening the US dependence on foreign sources of materials for the elements necessary to sustain our everyday lives. With the approval of this project, the US once again will produce critical and strategic minerals primarily sourced from China and elsewhere. This is a goal that has been endorsed repeatedly by the US House of Representatives.

We encourage the USFS to approve the proposed Stibnite Gold Plan of Operations EIS #50516.
