


Re: Gunnison Public Lands Initiative Initial Proposal

Dear Forest Supervisor Armentrout,

The Gunnison Public Lands Initiative (GPLI) is pleased to present its initial proposal for consideration and incorporation in the Grand Mesa, Uncompahgre, and Gunnison (GMUG) National Forest Land and Resource Management Plan revision process. The proposal is for new wilderness and special management areas on Forest Service and Bureau of Land Management lands in Gunnison County. Our initial proposal is the culmination of work that has been occurring in the county over the past five years to understand on-the-ground uses of our public lands and extensive collaboration to develop a consensus-based proposal that is supported by the diverse member group (described below). Its initial recommendations showcase the common ground and significant collaboration for public land protections that will best serve our community's economy, environment, and quality-of-life into the future.

The 2012 National Forest System Land Management Planning Rule requires the Forest Service to provide opportunities for public participation throughout the revision process, including in the development of the assessment.¹ The GPLI Working Group sincerely thanks Forest Supervisor Armentrout and members of

the GMUG planning team for meeting with stakeholders collectively and individually over the past several months to discuss the GPLI process, proposal, and relationship to forest planning. We acknowledge the request from the Forest Service for coordination and communication with the GPLI project. Therefore, included with this letter, per the agency's request, are the initial GIS shape files. We also included the initial proposal report.

The GMUG stated that comments received by August 31st, 2017 were summarized and incorporated where applicable into the draft assessments, but acknowledges that "later comments are still welcomed by the team and may be included in later versions."² We submit our initial proposal package with the sincere hope that its recommendations be incorporated into the GMUG's Assessment Report(s), Need to Change Statement, and Proposed Action.

The goal of the GPLI coalition is to protect public lands, enhance a strong and sustainable economy, and support historic uses of public lands. To accomplish this goal, the GPLI is crafting a consensus-based legislative proposal recommending that key public lands with exceptional recreational, wildlife, natural, grazing, scenic, scientific, and water values be permanently protected. Coalition members include:

The Gunnison County Stockgrowers' Association who work on the behalf of Gunnison Valley ranch families to ensure the continuation of local agriculture into the next generations.

Gunnison Trails is a non-profit trail advocacy organization established to assist land managers and other organizations and stakeholders in maintaining existing trails, educating users on responsible trail-based recreation, and pursuing new opportunities for biking, running, and hiking trails which promote sustainable trail use throughout Gunnison County.

High Country Conservation Advocates (HCCA) is located in Crested Butte, Colorado and has over 850 members. HCCA was founded in 1977 to protect the health and natural beauty of the land, rivers, and wildlife in and around Gunnison County now and for future generations.

Gunnison County Sno-Trackers, advocates for the sport of snowmobiling in Gunnison County.

The mission of the Gunnison OHV Alliance of Trailriders (GOATS) is to resist the closure of motorized trails in the Gunnison National Forest and the Gunnison BLM district. Founded in the spirit of cooperation, the GOATs work closely with other user advocacy groups to ensure the best possible experience for all user groups on our public lands.

Since 1983, the Crested Butte Mountain Bike Association's (CBMBA) mission is to build, maintain, promote, and advocate for responsible and sustainable trails in Crested Butte, Colorado, the Gunnison Valley, and beyond. CBMBA's purpose is to unite all trail users through sustainable and responsible trail practices, community trail building, and advocacy.

The Upper Gunnison River Water Conservancy District is an active leader in all issues affecting the water resources of the Upper Gunnison River Basin.

Backcountry Hunters and Anglers (BHA) seek to ensure North America's outdoor heritage of hunting and fishing in a natural setting, through education and work on behalf of wild public lands and waters.

The mission of The Wilderness Society (TWS) is to protect wilderness and inspire Americans to care for our wild places. Since its founding in 1935, TWS has worked closely with diverse interests who care about the future of our national forests. Their 700,000 members and supporters nationwide and, in particular, more than 19,220 members and supporters in Colorado are deeply interested in forest planning.

Trout Unlimited's mission is to protect, conserve, and restore the nation's coldwater fisheries and their watersheds for the next generation. TU is the nation's largest coldwater conservation organization with 150,000 total members, 11,000 belonging to Colorado's 24 chapters.

Since its first monthly meeting in February 2016, this diverse, community-based coalition has been guided by the following principles:

- Appropriate balance between the wilderness, recreational, wildlife, ecological, economic, cultural, scientific, and scenic values of public lands;
- Support for a strong, sustainable economy in Gunnison County;
- Respect for historic uses of public lands;
- Use of the best available science and all relevant information;
- Desire to find workable solutions for all interests.

Guidance in the Forest Service's 2012 Planning Rule directs forest plans to be science-based and informed by public involvement.³ As a diverse coalition of stakeholders focused on establishing a community vision for public lands in Gunnison County, we firmly believe that our proposal is not only compatible with, but in fact enhances, the 2012 Planning Rule's direction to develop forest plans that:

“... [w]ill guide management of NFS lands so that they are ecologically sustainable and contribute to social and economic sustainability; consist of ecosystems and watersheds with ecological integrity and diverse plant and animal communities; and have the capacity to provide people and communities with ecosystem services and multiple uses that provide a range of social, economic, and ecological benefits for the present and into the future.”⁴

The initial proposal we submit to you reflects a range of community values including ranching, mountain biking, motorized recreation, conservation, science, water resources, hunting, and angling. We are also supported by a broad and deep pool of community members, business, and organizations, as reflected in the support lists attached as Appendix A.

The fact that ten diverse stakeholder groups with distinct missions can develop and submit a proposal for wilderness and special management areas exemplifies the unique community values held in Gunnison County. But it also reflects the realization that our community is growing and changing. The increase in population in Colorado will likely correspond to greater numbers of tourists and a greater variety of users recreating on the Gunnison National Forest and other local public lands. At the same time, the Gunnison Basin has been identified as one of the state's largest and most important potential conservation areas, and possesses exceptional habitat for big game and coldwater fish. Meanwhile, ranching continues to play a vital role in the local economy, culture, and landscape. Climate change threatens ecological functionality and established expectations of what forests are supposed to be and to provide. This potential clash of values and uses, old and new, could cast our public lands into steep uncertainty and decline, or could provide an opportunity for crafting and implementing a shared community vision. Recognizing this, GPLI strives for the latter.

The assessment phase of forest plan revision is important because it identifies the need for change in the forest plan. The 2012 planning rule requires that an assessment evaluate “[e]xisting designated areas located in the plan area including wilderness . . . and potential need and opportunity for additional designated areas.”⁵ The drive of diverse stakeholders to seek consensus, and to compromise where needed, in developing and submitting the initial GPLI proposal to the GMUG demonstrates a need and opportunity for additional designated areas on the Gunnison National Forest. Established local interest and positive public support for the proposal show a need and opportunity for expanded landscape-level conservation in the revised GMUG Forest Plan.

Through careful analysis and vetting, the GPLI proposal identifies outstanding landscapes on the Gunnison National Forest for wilderness and special management and proposes that they be managed to reflect and preserve their special values. Under the 2012 planning rule, the Forest Service has options in how it establishes special management areas. For example, the Forest Service could choose to establish geographic areas or management areas for the GPLI-proposed special management areas, with associated plan components that assure that the identified special values are recognized and protected. The Forest Service could also choose to establish designated areas.⁶ The Rio Grande National Forest in its October 2017 Draft Plan established Special Interest Areas, and allocated them to Management Area 3.1.⁷ Establishing special management areas will contribute to the Forest Service’s obligations under the 2012 planning rule to provide for ecological integrity, species diversity, and social, economic, and ecological sustainability.⁸ The GPLI proposal’s balance of conservation and traditional uses also is consistent with the 2012 planning rule’s requirement that forest plans provide ecosystem services and multiple uses, such as recreation and range and grazing.⁹
