

Dear GMUG Planning Team,

The Gunnison Public Lands Initiative (GPLI) is excited to be a part of formal scoping for the Grand Mesa, Uncompahgre, and Gunnison National Forest (GMUG) forest plan revision and are thankful for the opportunity to help develop a management vision for U.S. Forest Service lands in Gunnison County. We thank the GMUG planning team and local district office for your communication and engagement with us in the pre-planning stages of forest plan revision.

Public land conditions, uses, and impacts are changing. Recognizing this, the GPLI Working Group came together in February, 2016 to find common ground on public land protection measures in Gunnison County. The Working Group is made of stakeholders from ten community groups, the Gunnison Board of County Commissioners, and Senator Michael Bennet's office. Interests represented on the Working Group include ranching, water resources, motorized recreation, conservation, mountain biking, hunting, and angling. In June 2017, the Working Group released an initial proposal for wilderness and special designations for community review and feedback. That proposal was submitted to the GMUG in November 2017. Since that time, the Working Group has continued to hold regular meetings, discuss the proposal with the community, and refine boundaries and management emphases based on public input. For example, the Working Group removed the proposed Beckwith Wilderness on the north side of the current West Elk Wilderness, have a new prescription that allows for winter

motorized recreation in the Deer Creek Special Management Area, and pulled back the boundary on the southern end of the Double Top Special Management Area to accommodate an area of highly valued winter motorized recreation in the Farris Creek and Strand Hill area. These, and any other changes, will be included in the revised proposal and submitted as a supplemental scoping comment.

The GPLI is a distinct, community-based endeavor, the result of a committed group of citizens working together towards a shared vision for sustainable public lands. Under the 2012 planning rule, forest plans must “reflect . . . the unit’s expected distinctive roles and contributions to the local area, region, and Nation . . .”¹ U.S. Forest Service lands within Gunnison County, and the experiences those lands offer, are distinct. This landscape’s unique ecological and recreational niche within the National Forest System and the broader landscape drives the Working Group. We believe that the GPLI proposal builds upon, and matches, this distinct landscape and community.

Located in the Central Rocky Mountains on the Western Slope of Colorado, Gunnison County covers 2.1 million acres - almost as large as Delaware and Rhode Island combined. Eighty-two percent of its area is federal public land administered by the Forest Service, Bureau of Land Management, or National Park Service. The County is home to over 15,000 people that live in three major hubs: Mt. Crested Butte, Crested Butte, and Gunnison. During the winter and summer months, however, the population explodes with visiting mountain bikers, backpackers, rafters and kayakers, skiers, hikers, dirt bikers, wildlife enthusiasts, snowmobilers, and campers.

Gunnison County is a true Western landscape. Elevations range from 7,500 to above 14,000 feet, with the landscape changing from sagebrush scrublands to high alpine tundra. Snow-packed mountains give way to the rushing waters, including the Gunnison River – one of the major tributaries of the Colorado River. These rivers supply water for drinking, habitat for the globally rare Colorado River cutthroat trout, and commercial, cultural, and recreational uses. These public lands provide habitat for some of the most productive game units in the state, are home to the Gunnison sage-grouse - which is listed as ‘threatened’ under the Endangered Species Act, and over a dozen other globally and statewide threatened plant and animal species. Residents and visitors value maintaining open space for the protection of scenery, wildlife habitat, the areas’ rich ranching heritage, and world-class recreation opportunities.

The GPLI proposal fits squarely within the requirements and purpose of the 2012 Planning Rule. The Rule states: “The purpose of this part is to guide the *collaborative and science-based* development, amendment, and *revision of land management plans that promote the ecological integrity of national forests and grasslands.*”² The GPLI is truly a collaborative, community-driven, science-based process, and the GPLI proposal promotes the ecological integrity of the Gunnison National Forest. It does this by balancing sustainable recreation with landscape-level conservation designations and management emphases. The GPLI proposal is a reasonable proposal for allocating Forest Service lands within Gunnison County, and as such must be reflected within the range of alternatives considered for the forest plan revision.³ We

respectfully ask that the GPLI proposal be incorporated into the revised forest plan and analyzed in one or more alternatives, including the proposed alternative, in the environmental impact statement (EIS).

Wilderness and Special Management Area Designations

The GPLI proposes that key public lands managed by the GMUG in Gunnison County be protected as either recommended wilderness or special management area (SMA). By using a range of designations and management emphases identified by stakeholders and the community, the GPLI seeks to conserve a broad set of lands, allow for sustainable uses (e.g., recreation, grazing, scientific research, and learning), and promote shared values (e.g., clean air and water, biological diversity, and wildlife habitat). While the GPLI's ultimate goal is legislation, the planning rule requires the GMUG to determine where and how to establish, or recommend, conservation areas in forest plan revision. These types of conservation areas include lands recommended for wilderness designation⁴ and other designated areas.⁵ The GPLI coalition made all its recommendations by consensus, meaning that all members of the group support the work in the proposal and overall package of recommendations. The areas in the proposal identified as "Considered for Special Management Area and/or Wilderness, to be vetted with regional communities" were recognized as key public lands, but the GPLI acknowledges the need to have a more in-depth conversation with regional stakeholders to fully understand the conditions, suitable designations, and appropriate boundaries.

Evaluating and recommending areas for conservation designation is one of the most important parts of the plan revision process. Conservation designations contribute to achieving the substantive provisions of the planning rule.^{6,7} In addition, they enhance the forest's capacity to

adapt to climate change.⁸ The GMUG explicitly acknowledges this in its Revised Draft Designations Assessment: “There is a need, per requirements of the 2012 planning rule, to consider additional areas for designation including areas suitable for inclusion in the National Wilderness Preservation System per FSH 1909.12 Chapter 70 . . . and to review existing information to evaluate what opportunities have been identified in the area and what needs could be met with other special designations.”⁹

Under the planning rule, the definition of “other designated areas” is purposely broad.¹⁰ Areas designated through the forest planning process have included research natural areas and special interest areas such as botanical, geological, scenic, zoological, paleontological, historical, or recreational areas.¹¹ The intent is to “[r]ecommend areas where doing so would help carry out the distinctive role and contributions of the plan area in the broader landscape or contribute to achieving desired conditions for the plan area.”¹² Plans “must include plan components, including standards or guidelines, to provide for . . . [a]ppropriate management of other designated areas or recommended designated areas in the plan area[.]”¹³

The GPLI Working Group prides itself on working diligently to identify public lands that should be managed by the Forest Service to maintain special character or purpose. Many are wilderness-quality lands, but possess other uses identified by the Working Group so as to preclude wilderness designation. Nevertheless, the distinctive values and contribution to the community from these “other designated areas” support their inclusion as SMAs with tailored management direction in the revised forest plan. Approximately 262,340 acres, or 52% of the GPLI initial proposal, is recommended for SMA designation. As noted in the Revised Draft Designations Assessment, “[t]wenty separate areas are proposed as special management areas

designed to provide protection for a variety of resources and uses, such as important species and their habitat, to provide for different suites of recreational activities to avoid user conflicts, and provide opportunities for scientific research with reduced conflicts with recreation uses[.]”¹⁴

The GPLI proposal conforms to the planning rule’s direction and advances the substantive provisions related to ecological integrity, diversity, sustainable recreation, integrated uses, and connecting people to the outdoors. Specifically, the GPLI’s combination of wilderness and SMA recommendations creates a network of protected areas that will contribute to the revised plan’s overarching goals of ecological sustainability, sustainable recreation, and climate change adaptation.

Recreation

Forest planning is the appropriate venue to consider the significant opportunities and challenges associated with recreation and to provide a sustainable recreation framework for managing this use. The 2012 planning rule requires the plan “to provide for . . . [s]ustainable recreation.”¹⁵ The multi-year, multi-stakeholder process that has informed the GPLI proposal should inform and shape the development of plan components and recreational zones to meet the rule’s substantive recreation requirements.

The GPLI strives for balance. Mechanized and motorized recreation are important economic drivers in Gunnison County, yet so are the unsung ecosystem services provided by wilderness lands. On the one hand, the proposal’s wilderness recommendations promote ecological integrity while sustaining primitive, non-mechanized recreation. On the other hand, the proposal’s SMA recommendations maintain landscape-level conservation, while not abridging existing mechanized and motorized use. In fact, several of the SMAs specify opportunities for additional, limited mechanized and motorized recreation. The GPLI proposal constitutes a “known opportunit[y] to highlight unique recreational or scenic areas in the plan area to provide for sustainable recreation opportunities[.]”¹⁶

In addition, the GPLI proposal ensures that ecosystems and wildlife habitat are connected across the landscape to safeguard movement of elk, mule deer, and other game species. This will help sustain the hunting economy that is so important to Gunnison County. The proposal’s strong watershed protections will contribute to the continued viability of fishing. According to a report released in February 2017, Gunnison has the highest fishing economic impact - including retail sales, salaries, jobs and tax revenues - of any Congressional district in the state.¹⁷

In the Revised Recreation Assessment, the GMUG identifies several Key Issues, including the following:

- “Based on public input, non-motorized and motorized settings and opportunities are not meeting the preferences of users in some areas on the forests, during both summer and winter.”¹⁸
- “Forest Plan direction for summer recreation settings is inadequate to be able to manage for specific settings, especially concerning size and location of motorized and non-motorized settings.”¹⁹
- “Environmental impacts of recreation activities and use are important considerations.”²⁰
- “Provide strategic direction to ensure that recreation opportunities are sustainable.”²¹

The Working Group tackled the above key issues head-on over the last two years, and the GPLI proposal offers well-reasoned, community-supported action to address these key issues.

Water and Ranching

The planning rule states that forest plans must provide for ecosystem services and multiple use, including range and watershed.²² Ranching, and healthy waters that sustain ranching, are cornerstones of Gunnison County’s economy and culture. Both are critical factors in Working Group deliberations and identification of areas for designation in the proposal. Importantly, the GPLI proposal ensures that current ranching operations and water use can continue into the future. In the same manner that the areas of consensus in the GPLI proposal do not close any roads or trails that are currently open, neither does the proposal abridge any existing grazing permits or water rights. Protecting existing ranching and water use were priorities for the Working Group.

While each user group has their own motivations, for the ranching community, the GPLI helps define the guardrails of use within grazing allotments. It allows ranchers to create long-term plans to achieve rangeland health and operational goals, which will be crucial to economic and ecological sustainability. Inherent in the county’s agricultural model is the integration of private and public lands, and the viability of public lands grazing has implications that are far reaching. Local ranching operations are essential to protecting intact landscapes, from streambed to ridgeline. They continue a generational and uniquely local food production system, and sustain the verdant viewsheds that are so widely appreciated.

Land use is closely correlated with the water quality of rivers and streams. Healthy, functioning ecosystems filter runoff, cleaning water resources. Protecting lands from new mining, oil, gas, road building, and other development also protects watersheds from pollution and sedimentation caused by industrial activity.

Climate Change

Every stakeholder on the GPLI Working Group has experienced, and is concerned about, the impacts of climate change on public lands in Gunnison County. The planning rule requires substantive plan components addressing climate change. The rule states: “The intent of [the 2012 planning rule’s] framework is to create a responsive planning process that informs integrated resource management and allows the Forest Service to adapt to changing conditions, including climate change . . .”²³ In addition, forest plans “must include . . . plan components . . . taking into account . . . climate change, and the ability of terrestrial and aquatic ecosystems on the plan area to adapt to change.”²⁴

While climate change was not the impetus for the formation of the GPLI, it did significantly influence the Working Group’s process and direction. For example, Working Group members with a primary interest in ranching desired the following goal in the proposal’s recommendations: “Relieve increasing pressure on ranching from climate change and increased recreational use.”²⁵ By utilizing both wilderness and SMA designations to protect large tracts of intact habitat, the GPLI proposal will help our ecosystem adapt to a changing climate. Protecting and connecting undeveloped areas is an important action the GMUG can take to enhance climate change adaptation.²⁶ Other land management agencies identify connectivity as a key factor for climate change adaptation, along with establishing “blocks of natural landscape large enough to be resilient to large-scale disturbances and long-term changes.”²⁷

Generally, all of the wilderness areas on the GMUG National Forest are high elevation. An objective of the National Wilderness Preservation System is a system of lands that reflect the rich ecological diversity of all of the lands across the United States.²⁸ The GPLI proposal conserves lands from valley floors to 14,000-foot peaks, protecting a wide elevation gradient and serving as an important strategy for climate change adaptation.

Conclusion

The Revised Draft Designations Assessment asks: “Has a need or opportunity for specific designated areas been identified in the plans of States, Tribes, counties, and other local governments?”²⁹ Gunnison County was the convener the Working Group for Public Lands - now called the GPLI - and is an ex-officio participating member.
