Note, I attempted to use the linked form and got an error message (screen shot attached). I encourage extension of the comment deadline.

I missed that this project was open for review and have not had a time to carefully review the EIS. I have rowed and camped much of the shorelines of Kupreanof Island, Kuiu Island, east Wrangell Island, and Bradfield Canal, and spent time on Mitkof Island, including hiking in old clearcuts.

I strongly object to any additional targeting of old-growth. The ecological values of old-growth are not fully known. We should be protecting and defending all last remnants.

I strongly object to building any new logging roads into areas designated as roadless as of 1/1/2018.

I have volunteered on invasive weed pulls with the USFS/SEACC partnerships at Whitewater Bay and Gambier Bay on Admiralty Island. Those experiences lead me to be hyper aware of invasive plants and their spreading and impacts. On Chichagof Island in July I observed that reed canary grass had spread from the logging road hundreds of yards downslope through old clear cuts well out into a large muskeg meadow. Roads and trails are vectors for invasives. Vehicles, people, and wildlife spread them further. Areas where bears have tilled the beach fringe create disturbances that gives invasive species an extra foothold over beach rye and other native plants. About five miles from our project site I was hiking when we were waiting for weather and was inspired to look for our target invasive where a bear trail passed through the beach fringe. Invasive present. Just a couple of plants, that year. Almost impossible to see how it can be controlled once underway.

That said, I have serious concerns about the use of toxic herbicides to address invasive species. Hand pulling and tarping is intensive and difficult, which is why prevention is so critical. Until we have the resources to fix what has already been broken, do not break anymore. Keep roadless areas roadless and be cautious about building any new trails into wild areas as well.
