

Dear G-MUG Planning Team,

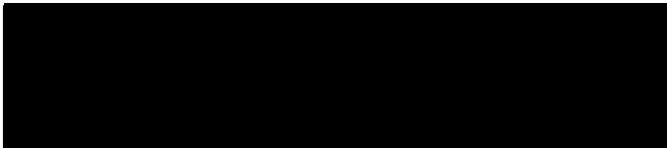
It is great that you provide an opportunity to comment on the plan for treatment of G-MUG forested area. This is an area I have chosen to live in for my retirement years.

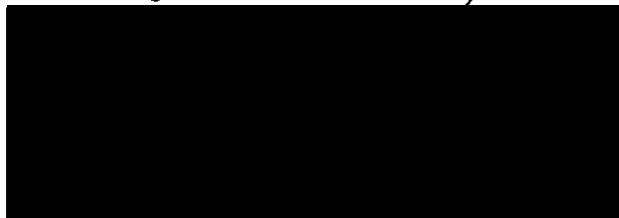
I am writing to request an extension of a minimum of 45 Day Comment Period.
