THE BELOW SIGNATORIES ARE IN SUPPORT OF THE NEZ PERCE-CLEARWATER NATIONAL FOREST'S "FOREST PLAN REVISION": "ALTERNATIVE X"! TO WIT: NO MORE WILDERNESS AND SCENIC-WILD RIVER AREAS IN THE NP/C NF; MORE VEHICLE AND OFF-ROAD VEHICLE ACCESS ON NF ROADS (OPEN CLOSED ROADS AND DO NOT CLOSE OTHER ROADS!); EXPANDED OPPORTUNITIES FOR LOGGING, MINING, AND, OTHER ACTIVITIES; ETC.

Alternative "X" allows for more access to U.S.F.S. roads (and not closing them off to the public and ATV use); and, more logging and mining activities in the NP-C NF.
