Dear Forest Supervisor Avey:

Western Watersheds Project requests to be added to the Interested Public mailing list for all grazing management activities including, but not limited to, grazing allotments (see list below), range improvement/development projects, lease and permit renewals, standards and guidelines assessments, field visits, resource management planning, allotment management planning, vegetation treatments relevant to grazing operations and fuel reductions, and permit transfers for these grazing allotments. This also includes:

- Designating or changing allotment boundaries.
- Increasing or decreasing the total number of animal unit months of specified livestock grazing.
- Modification of terms and conditions of grazing permits.
- Development or revision of Allotment Management Plans.
- Planning range developments or range improvement programs.
- Issuance or renewal of grazing permits.
- Reports which evaluate monitoring data (i.e. allotment evaluations).
- Issuance of non-renewable grazing permits.
- Closures of allotments due to drought, fire, flood, insect infestation, or when continued use would pose significant resource damage.
- Transfers of grazing permits.
- All mechanical, prescribed fire, herbicide/chemical and biological fuels projects. This includes both Wildland Urban Interface Projects and Non-Wildland Urban Interface Projects
