As we all know, with the change in administration, the Forest Service is shifting from OG management to YG management. This makes the Thomas Bay EA a big priority for district and region. It will be one of the first YG projects on the Forest.

We will also be working on a smaller YG management EA – Upper Falls Creek to meet recent developments with the local Falls Creek mill. There is a potential demand for volume exceeds what the

district currently has NEPA cleared under the Mitkof Island Commercial Firewood or Individual Tree Sales Decision Memo.

Thomas Bay EA

- Field work should be complete across all resource groups, and information updated in GIS, as needed.
- Scoping will begin on 8/20 starting a 30-day comment period
- In September, will talk more about what EA process will look like new templates and guides available from WO (see table below for some of the milestones ahead)
- Will try to keep TB working alongside the Upper Falls Creek project to minimize workload
- GIS Update (Ben and Caster)
 - > Timeline Reminders
 - ➤ Gene has a place for Thomas Bay and Upper Falls Creek on the T drive and there is also an AGOL group in Arcgis for both projects. Layers include units and roads.
 - Caster will make sure that everyone on IDT has the permissions needed to access the GIS files
 - Gene is taking the lead on TB. Caster is backup.
- Expect NEPA work to pick up for Thomas Bay in late September once we have public comments in hand.

Upper Falls Creek EA

• Ben sent out an email (8/4) with the following information about the project

What's being proposed: Environmental Assessment of approximately 43-acres of commercial young-growth harvest and the construction of up to a ¼ mile of temporary road.

Where: Mitkof Island in the Falls Creek watershed.

How: Even-aged management (clearcut) of two separate stands, using ground-based equipment. Logs would be yarded to existing FS roads 6235 and 6204, or new temporary road.

When: Scoping for this project is planned for August 20 with a release of the EA and FONSI/draft DN in October and a DN signed this calendar year.

Why: Recent developments with the local Falls Creek mill has generated interest in young-growth timber opportunities. This potential demand for volume exceeds what the district currently has NEPA cleared under the *Mitkof Island Commercial Firewood or Individual Tree Sales Decision Memo*. Additional NEPA cleared young-growth volume on the Mitkof Island road system would provide an opportunity to help meet potential demand.

- Scoping is slated to begin this month. Carey and Marina will work with Ben to get all materials ready for distribution to the public.
- Potentially some temporary road extensions
- Two units being cleared about 20 acres each
- Caster is taking the GIS lead on Upper Falls. Gene is backup.

PRD/WRD Invasive Plant EA

- Draft EA/FONSI will be made available this month, and a 30-day comment period will begin. Carey doesn't anticipate much work needed from specialists following the comment period; however, there is a potential for objections.
