Dear Ranger Morgan:

Please allow me to take this opportunity to express my support of the Upper Cheat River Project. The Division of Forestry and the Division of Natural Resources are two of the agencies that comprise the Department of Commerce; therefore, I am well aware that the conditions on the Monongahela National Forest are believed to be less than ideal to preserve the forest, promote wildlife and minimize natural disasters.

After consultation with agency leaders, I am confident that the approval of the proposed 10-year plan for the Upper Cheat River Project would implement a more aggressive silviculture management practice designed to alleviate many of our concerns. Specifically, I am excited that the implementation of this plan will improve the overall health of the forest, identify and reduce invasive species, diversify wildlife habitats, increase harvesting and minimize the threat of wildfires.

Additionally, the forest-products industry is a major economic driver in West Virginia contributing an estimated \$3.4 billion to the state's economy annually. I have heard concerns from business representatives regarding the lack of available raw materials necessary not only to meet demand, but also to sustain the industry in the foreseeable future. An increase in harvesting mature timber stands would greatly assist the industry in meeting future needs and continuing its

contribution to the state's economy by providing invaluable jobs, raw resources necessary to supply manufacturers and contributing much needed revenue to our local communities.
