I would like to comment on the current proposal number NZ-19. This seasonal closure is not warranted. SNF is only proposing this to have common seasonal dates across the forest. This is not a valid reason. This road has no erosion issues, has little impact to wildlife, and provides a high value experience. Local people use this road to access the forest when other areas are closed. The historic use has been predator hunting, mountain lion hunting, spring bear hunting, winter photography, an access point to cross country ski, snowshoeing, etc. The SNF needs to take into account the fact that someday there will be a wolf season, and we need access to these type areas to control them. We also need to keep low impact areas open, to help disperse use across the forest. Perhaps an alternative would be to monitor this road and to keep it open as conditions allow.

There are options for the SNF to be able to maintain this portion of the road. State parks and trails have a maintenance team available to handle this type of issue. There is also a local OHV group that has expressed a willingness to enter into a MOU to provide funding, and man power to accomplish maintenance on the road system.
