

Proposed additional ATV Trails on existing closed roads.

Priority No. 1 through 4

1. Sheridan Basin to Parking area at Snowmobile Oval. All on existing closed road and is a groomed Snowmobile Trail. USFS road No. 622 to tie into USFS No. 540
2. Double Cabin to Indian Point Road. This was a maintained ATV trail. The ATV Club helped maintain this trail. Closed by USFS recent years. USFS road No. 285.4 to tie into USFS No. 556.
3. Salt Barrels Park / Windy Mountain/ Little Warm Spring Road. This area is on an existing road used to access electronic site on Windy Mountain and ¾ of a mile unofficial ATV Trail tying in to the Moon Lake ATV Trail. USFS road 524 to tie into USFS 283.
4. No Mans Road to Camp creek Trail. Old logging road, mostly on groomed snowmobile trail. Could hit Camp Creek Trail at Big Rock or come in near top of ridge on snowmobile trail. USFS road No. 732 to ATV Trail No. MT11.

Other Potential Trails Not Listed in Priority

5. Kitten Creek (No Loop). This would be about 2 miles on existing Road beyond closed gate. USFS road No. 605.
6. Geyser Creek- Upper Little Warm Springs. Ties USFS Road 554.1E to USFS road 600.
7. Warm Springs Look Out (No Loop). Old existing road though Subdivision (there is question on right-of-way). However there is a possible route on existing closed Jeep Road that runs up hill South along USFS Boundary. USFS road No. 663 to old Look out sight on Warm Springs Mountain.
8. Grandy Reservoir on existing logging road. Off of USFS Road No. 554.
9. Rim Trail- This is a groomed Snowmobile Trail on old Jeep Road. USFS road No. 534 to USFS road No. 538 / No. 622.
10. Cow Creek is a groomed Snowmobile Trail mostly not on existing road, but is mostly open easy country for ATV Trail. This would connect USFS road No. 534 on Salt Ridge to USFS No. 533 near the Old Johnson Cow Camp.
11. Bachelor Creek. Once used for ATV's access to Moon Lake Trail. Half on old closed logging road and half on unofficial ATV Trail. Currently closed. USFS road No. 554 to ATV Trail MT 14.
12. West Fork of Long Creek. Closed old road between West Long Creek road and Middle Fork of Long Creek road. USFS No. U659.1 to USFS No. 548.1D.

We are currently working with Town of Dubois, B.L.M. and Wyoming Game and Fish on access to Moon Lake Trail from Town of Dubois property near Rodeo Grounds to tie to USFS road No. 524.

We feel we must maintain all currently open existing roads and trails.
