2. On the same field trip, a dude ranch operator said ATV traffic in that exact area was killing his trail ride business. Continued use on 622 would be detrimental to this historic business. The ranch has been using this section of forest long before ATV.
3. Elimination of motorized travel on 622 will improve hunting opportunities. There is good access up Sheridan Creek and on Lava Creek. Foot and horse hunters will benefit by not cutting-up this area with motorized travel on 622.

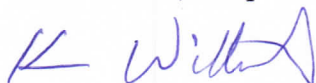
