**Asseveration of Proposed Action #58831, LEMON GULCH TRAILS PROJECT**

**AFFIDAVIT OF TRUTH and OBJECTION TO #58831**

**AFFIANT IS COMPETENT TO TESTIFY**

AFFIANT is WARNING the USDA-FOREST SERVICE OF DANGERS OF #58831

- a. Unsupervised Camping and Unauthorized Camp Fires.
- b. Lack of Law Enforcement for any part of Project 58831.
- c. Likely dangerous use of Intoxicants.
- d. Well know fact tht 80% of Forest Fires are caused by Humans.
- e. Nationwide advertising and exposure would bring about overcrowding of the area.
- f. Lack of communication to alert Fire or Medical Emergency Services.
- g. Emergency Fire Response over 2 hours away.
- h. No access for Emergency Medical Equipment.
- i. SEAT or HELICOPTER RESPONSE to a Fire is not guaranteed.
- j. No EMS Helicopter landing sight proposed or approved by the FAA or USDA.
- k. Closest water is over 8 miles away to fight a Fire.
- l. No ground transportation provided for EMS patient transport on site.
- m. Crook County will be in a Severe Draught as attached Map depicts.
- n. Predominate wind in Crook County is from the NW, Prineville Airport Runway 29.
- o. 75% of Prineville Airport Traffic is into the wind, 290 degrees, on Runway 29.
- p. The Property downwind from 58831 is Private Property with homes and animals.
- q. The only way to evacuate is South on Mill Creek Rd..

The Human Impact of 58831 is Severe for Mill Creek Area Residents As:

- a. Anxiety and worry about Fire Danger would be never ending.
- b. Residents would be unable to freely travel, hunt and fish for worry of Fire Danger.
- c. The Cost of Insurance or Denial of Coverage would occur because of Fire Danger.
- d. Property Owners would be unable to relocate their animals should a Fire happen.
- e. Property Values would decrease because of 58831.

**This Trails Project should never have been considered at Lemon Gulch because of the Fire Danger To Private Property Owners. If the USDA-FOREST SERVICE had Notified All of the Property Owners adjacent to 58831 at the very beginning as required, ALL OF THE CONCERNS OF THE PRIVATE PROPERTY OWNERS WOULD HAVE BEEN PRESENTD AT THE BEGINNING. RATHER THAN THIS LATE DATE.**

**USDA-NATIONAL FOREST has thousands of acres available that are not adjacent to Private Property that would be more suitable to Mountain Bikers and of no concern to Private Property Owners that are not in close proximity to the Project.**

**It is not to late to realize that Mountain Bikers could enjoy a much larger project, that is more challenging, better planned and does not have the negative effects that 58831 presents..**

**All the facts stated herein are true, correct, and complete in accordance with Affiant's best firsthand knowledge and understanding, and if called upon to testify as a witness, Affiant shall so state.**

#### **DEMAND FOR MITIGATION**

Due to the lack of DUE DILIGENCE by the FOREST SERVICE to address these concerns and properly notify the Mill Creek Property owners as required by regulation; a Environmental Impact Statement should be made, NO ACTION SHOULD BE TAKEN.

Affiant believes the USDA-FOREST SERVICE LACKS THE EXPERTISE TO ADDRESS ALL THE ISSUES as demonstrated by the issues presented herein.

This instrument applies to the Proposed Action #58831, LEMON GULCH TRAIL PROJECT by the USDA-FOREST SERVICE as it effects the Affiant, **Joyce Milliron**, for the following reasons to wit:

The Right of Affiant as recognized and so stated by our forefathers in the Declaration of Independence, are Unalienable.

The Right of Affiant to be secure in his person, house, papers, and effects is recognized and so stated in Article Four of the Bill of Rights of the Constitution of These united States of America.

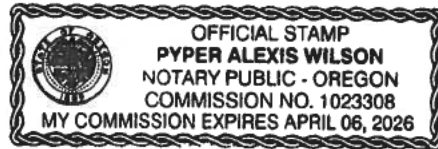
