The South Dakota Department of Agriculture and Natural Resources provides the public with a "Tank, Spills, and Environmental Events" interactive map that includes data and reports (<u>https://apps.sd.gov/NR42InteractiveMap</u>).

The State's Minerals, Mining, and Superfund Program regulates statewide mineral exploration, mining, and oil & gas development; and conducts statewide Superfund assessments and regulatory oversight at Superfund sites in South Dakota.

The following Data collection below from SD DANR is for the Northern Black Hills from 1983-2023. There are several incomplete "Spill" reports that the mining company submitted to the State as required. This incomplete data leaves holes in a complete and accurate account of how many gallons, cubic yards, barrels, or tons. The state reporting form does have a portion to indicate the amount and units.

According to the Minerals, Mining, and Superfund Program staff at the May 18th hearing on the Wharf Resource's Boston Expansion Project, reports that are missing important information WILL NOT be updated in the State DATABASE.

The majority of the spill materials reported include Cyanide Solution. Other fluids include; Acid Rock Drainage, ANFO Solution, Hydraulic Fluid, Diesel, Antifreeze, ect. Major causes are; Equipment Failure, handling, leakage, runoff, spillage, etc.
