RE: Nez Perce Tribe's Preferred Wild and Scenic River Designations and Rationale

Dear Ms. Probert:

The Nez Perce Tribe ("NPT") is providing the Nez Perce-Clearwater National Forests ("Forest") an updated list of Wild and Scenic River reaches based on the Forest's Outstandingly Remarkable Values criteria. The list follows this letter. The list is <u>not</u> an exhaustive list of the resources and values NPT deems culturally and ecological significant and worthy of protection.

The NPT technical staff is supportive of all stream reaches identified by the Forest planning team, with the following amendment:

• NPT does not support the use of mining as a historical criterion for designating Crooked River. Historic mining was a major contributor to degrading water quality and stream structure.

In the attached list, NPT has added some additional reaches to the Forest's July 17, 2017, list of preliminary eligible Wild and Scenic River reaches. NPT has also provided its specific rationale for its additions to the Forest's list, as requested by Zachary Peterson, Forest Planner. NPT is happy to clarify any remaining ambiguities.

Additional feedback on hot springs:

As the NPT has previously stated, the hot springs on Jerry Johnson Creek and Weir Creek are very special to the NPT, unique to the Forest, and in need of specific protection. These hot springs also meet the Wild and Scenic geologic, historic, cultural, wildlife, and recreational criteria. Thus, in

July 2017, the Forest Planning team and NPT's technical team discussed whether these hot springs should be protected by a Wild and Scenic designation. At the time, NPT staff was not sure if the watersheds containing these highly popular hot springs were already protected or whether the Forest had other means of protecting them.

Thereafter, Forest Planning staff shared with NPT staff a draft Recreation Desired Future Condition ("DFC") that it had developed to specifically ensure a high level of integrity for these hot springs' characteristics, functions, and uses. NPT staff provided the Forest with some minor changes to the draft Recreation DFC via e-mail. NPT believes that, if its recommended changes are adopted, the hot springs will have sufficient management protections, negating the necessity for Wild and Scenic designations for the hot springs and their associated watersheds.
