I believe there still is very little forest thinning with the goal of preserving important ecosystems vitally important to a variety of birds, mammals/riveroverall flora and fauna plus water sources such as springs, streams, rivers and riparian corridors. I believe comprehinsive wildlife surveys should be put in place prior to a timber sale being sold, especially in areas of prime habitat and large trees (and this is because agencies have a limited staff of Wildlife Biologists and possibly contractors who can plan and do this important work. Surveys cannot simply be a few weeks or months: I believe they should be conducted at least 3-5 years and, if possible, year round (like Spring, Summer, Fall, Winter). In many instances, I think habitats are shrinking or are fragmented without taking into account what makes these areas home for a variety of flora a fauna resulting in biodiversity. Our future, for ALL ages, depends on scientific reviews—on the ground, not simply on a computer model—so the best decisions are made that impact our Forest Service lands (+ BLM and Privately owned lands). I see the REAL FUTURE of forest mangement and timber harvesting of live trees, especially large live trees (as well as harvesting fire burned/salvage trees), based on scientific data and not simply the amount of board feet that can be harvested. I didn't fully read the NW Forest Plan when it was introduced in 1994 but I believe these key factors were part of it's main intention(s) and it's important to keep those in mind going forward.

In 2024, the stakes are far higher than they were when the NFP was adopted in 1994. Many, many wildlife populations are in severe decline; climate change impacts approach levels where our Earth is unable to recover and becomes more unstable, and local economies are increasingly significantly affected. That is why it is important to strengthen the protections in the NFP. The NFP had a great framework and policies, but the plan is skewed toward timber production which is detrimental and unsustainable. The most concerning is the continued loss of old growth trees, so critical for carbon sequestration in a warming planet. According to some of the more recent inventories done by the Forest Service and the BLM, 45% of forests are found to be "mature" and ONLY 18% ARE CONSIDERED OLD GROWTH. That is for the lower 48! Logging needs to be limited to a much greater degree in forests considered "mature". The NWFP requires that 80% of LSRs be restored to late-successional condition, but currently only about HALF of those areas exhibit these qualities. Wise management of mature forests become key in future old growth retention. Logging has been allowed in too many sensitive watershed areas. Logging roads have greatly decreased the quality of riparian areas. This causes problems for aquatic wildlife and also leads to degradation of watershed areas.
