It is essential that this amendment include protection for all old growth AND mature trees and forests Mature forests are future old growth. I am sure you are aware of many of the benefits.

These include preserving carbon sinks to help combat climate change; protecting endangered species such as the spotted owl, marbled murrelet, Pacific salmon, and others pending inclusion under the endangered species act; increasing forest fire resistance; enhancing local economies not only through timber sales but clean water, climate stability, and outdoor recreation.

I would also suggest that incorporating tribal wisdom and practices into forest management of could be of significant benefit.


