We do support some minor adjustments to the current camping facilities and recognize the need for potential growth in primitive and semi-primitive campgrounds. However, we do not support the proposal of multiple buildings, employee housing, and maintenance buildings, which would significantly alter the character and environmental balance of the area.

In conclusion, we urge you to reconsider the proposal to develop Sweetwater Lake as a state campground. The potential environmental degradation, coupled with the social and cultural impacts and the increased traffic on Colorado River Road, outweigh any short-term economic benefits. Protecting Sweetwater Lake is not just a matter of preserving a natural resource; it is about safeguarding the heart and soul of our community for generations to come.
