Dear Ranger Molly Juillerat and staff,

Thank you for distributing the Revised Project Proposal for the Middle Fork/Bedrock Fire Affected Roads. Our firm, Cascade Timber Consulting, Inc manages approximately 145,000 adjacent to the USFS Sweet Home District. This land has been held as a working family forest for over 100 years! A decade ago, I would not have seen the importance that fire, road access, and forest management would play on lands well beyond our land's footprint.

I appreciate the objectives that your proposal clearly lays out:

Reduce the risks posed by fire-killed and injured trees that have fallen across or remain standing along important access routes of the fire-affected road system so that access to and through the burned area can be restored. The risks of primary concern in this project include:

- Public and forest worker safety and ability to use roads,
- Firefighter access to new ignitions,
- Usability of potential evacuation routes,
- Hazardous fuel loads,
- Functionality of roads as potential fire control lines, and
- Road infrastructure damages and failures.

As a trained single resource fire boss, I can attest that one of the most important strategies for fighting fire effectively and safely is access. Roads that are open and maintained do well to provide quick response for fire suppression. Small fires are safer, cheaper, and limit the severity of resource damage. Maintained access will help facilitate future fuels projects as well as the salvage of dead and dying forests. Neighboring lands such as ours are protected when our public lands are managed, and access is open.

I suggest that the following roads remain open or in some cases reopened and maintained at level 2 or greater (where feasible).

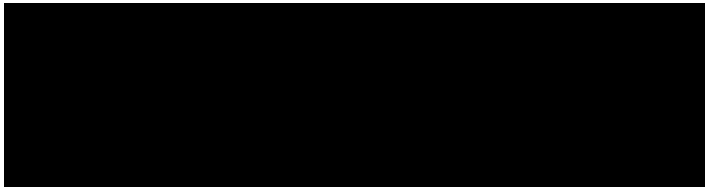
The mission of the Forest Service is to sustain the health, diversity, and productivity of the nation's forests and grasslands to meet the needs of present and future generations.
