**RE: Tongass Land Management Plan- Draft Assessment**

Dear Ms. Mathews,

United Fishermen of Alaska (UFA) is the statewide commercial fishing trade association representing 35 commercial fishing organizations participating in fisheries throughout the state and the federal fisheries off Alaska's coast. UFA has reviewed the U.S. Forest Service (Forest Service) Tongass Land Management Plan (TLMP) revision, Tongass Draft Assessment. The assessment appears comprehensive, and mostly adequate from the commercial fishing industry perspective.

Before and during the plan development phase of the Tongass National Forest Land Management Plan revision, UFA asks that all current salmon habitat, stream classifications, restorations, enhancements and protections be maintained. We urge the Forest Service not to alter or weaken the Tongass Timber Reform Act, and State of Alaska Air and Water Quality Standards.

We advise the Forest Service to maintain all existing language surrounding water quality, timber harvest, stream designations and riparian zone protection.

Chiefly, we ask the Forest Service to safeguard our fishing industry use of harbors and safe anchorages, near shore commercial fisheries, shellfish pot storages, aids to navigation, communication and weather forecast data sites, and permit agency and private non-profit salmon hatchery efforts in the Tongass including Wilderness waters.

We seek to magnify, maintain, and safeguard all elements of the TLMP that benefit Alaska's commercial fishing industry traditional historic connection to the Tongass.

We ask that the team responders for the plan development phase of the forest plan revision give expedient notice of all requested or suggested alterations of the existing TLMP to the public.
