On February 11th, 2015 we received the original copies of the Draft Forest Plan Revision. At the June 30th meeting at the Tri County Economic Development Office an Economic Analysis of Outdoor Recreation in Washington State and the R6 Sustainable Recreation Strategy Summary was discussed that would impact our statement regarding the Forest Plan Revision.
