Comments: Mr. Stewart, on August 21, 2018 I submitted 12 pages of scoping comments. I identified the laws you would violate if you implemented the Proposed Action for the Central Tongass timber sale and how you might change the proposed project to reduce the resource damage and make it "ecosystem friendly." Your IDT ignored my comments, therefore I won't waste my time providing specific comments on your DEIS because they will ignore those eoo. I mistakenly assumed there were professionals on your IDT.

Below you will find a summary of my assessment of how the recreation and fisheries resources will be affected by this sale. I also identify the people who will be negatively affected.

I worked with a District Ranger in the early 1990s who was clinically obsessed by the need to generate volume like you to assure future promotions to positions with more power and pay. She resigned. The rumor was her resignation occurred after a meeting with the R-1 director or personnel management. Her resignation announcement came shortly after her trip to the RO in Missoula, Montana.

The Central Tongass, South Revilla, Wrangell Island and Prince of Wales timber sales will clearcut many, many acres of old-growth trees in the rainforest. Some of the old-growth trees that will be clearcut are 400 to 600 years-old. They were mature when Columbus discovered America. This is what the tourists from many locations around the world pay good money to see. Here is information describing the Proposed Actions from the EISs, a ROD and Scoping Package for the sales. They each describe the level of old-growth destruction.

Central Tongass

"Timber offered for purchase is expected to total a maximum of 150 MMBF of old-growth timber and 80 MMBF of young-growth timber for a total volume of 230 MMBF over 15 years over the entire project area." (DEIS Volume 1 pg iv)

"As part of this analysis, the Forest Service is analyzing a project-specific Forest Plan Amendment Figure 2). 1 that responds to Issue 1. The amendment would lower adopted Scenic Integrity Objectives (SIOs) (USDA Forest Service 2016a, p. 4-54) to allow more efficient even-aged management on a greater number of acres within selected portions of Timber Analysis Areas." (DEIS Volume 1 pg 2)

"To support harvest and other activities, approximately 22 miles of NFS road construction, 82 miles of temporary road construction, and up to 70 rock quarries are proposed. An estimated 71 miles of closed NFS roads could be

improved for haul. These access improvements may include up to 37 new stream crossing structures, such as culverts and bridges.(DEIS Volume 1 pg 25)

"The proposed action would authorize the harvest up to 46 million board feet of timber from up to 5,500 acres of old-growth forested land"

Silvicultural prescriptions include approximately 3,359 acres of uneven-aged management (implemented using the single-tree or group-selection harvest method) and 1,408 acres of even-aged management (implemented using clearcut or clearcut with reserves harvest methods)" (FEIS at pg iv)

"require the construction of approximately 16.8 miles of National Forest System (NFS) roads, the reconditioning of 4.4 miles of road and construction of approximately 9.9 miles of temporary road. (FEIS at pg ii)

Prince of Wales

Log "up to an average of 25 million board feet (MMBF, volume measurement) of old-growth timber annually from suitable timber lands may be offered during the first 5 years of implementation, and up to an average of 15 MMBF of old-growth timber annually during the next 5-year period. An evaluation of the amount of old-growth timber remaining within the project area would occur 10 years after the decision, to determine if economical offerings are still available from the suitable timber land base during this last 5-year time period. This evaluation would be conducted using the Implementation Plan process (Appendix 2). Based on this evaluation, up to 10 MMBF of old-growth timber may be offered for years 10 and 11 of the project and up to 5 MMBF of old-growth timber for the final 3 years." (ROD at page 2)
