I strongly urge you to oppose the opening of 10 million acres of land in Alaska's Tongass National Forest for mining and logging projects. This would severely compromise our last remaining truly wild forest and be a huge blow to biodiversity. These lands are home to pacific salmon, iconic bald eagles, southern resident orcas, and even a 1000-year-old tree! It also contains the traditional homelands of the Tlingit, Haida and Tsimshian Peoples.

Beyond its natural beauty and cultural importance, the Tongass Forest is one of the world's best climate defenses. The old trees store nearly 10-12 percent of all carbon consumed by America's national forests -- and it's Alaska's first defense against the worsening climate crisis.

These lands must be protected and I urge the agency to take action to block this destructive proposal.

We must not allow this proposed legislation to authorize the terrifying step of reducing our ability to comment on or understand the effects of projects that impact these lands and wildlife. Allowing the Forest Service to choose this backhanded secretive mode of setting up provisions that promote the deliberate destruction of our public lands and forests by commercial interests violates both its mission and any trust formerly placed in this government agency - - and other branches of government. I have major concerns about the proposed expansion of the use of categorical exclusions for logging projects, road building, and all other forms of destructive, exploitative development; the shocking elimination of public scoping; and removing Inventoried Roadless Areas and potential wilderness areas from certain fundamentally necessary NEPA requirements, among other concerns. This proposal is one that only supports the short-sighted greed of a few corporate interests, and must be soundly rejected. NEPA is a bedrock environmental law that informs science-based, honest, transparent, and accountable decision making, but this proposed rule would obviously and deliberately weaken those vital standards in light of nothing more than short-term financial benefit for a handful of unaccountable special interests. I ask all those who stand with Friends of the Earth, Audubon, First Peoples, and the bedrock protective provisions of our public lands to join me in working actively to reject this proposal and any and all others like it.
