Statement of issues and/or parts of the plan revision to which the objection applies:

The Greater Yellowstone Ecosystem, of which the Custer Galatin is a part, is sadly the only remaining intact ecosystem left in the lower 48 states.

Biologist Ed Wilson has stated that the global extinction crisis may be directly threatened to human survival than global climate change1 and he advocates for preserving habitats in reserves large enough to maintain wild populations sustainably.

The Greater Yellowstone Eceosystem is one such place but for it to maintain its health ad biodiversity, the wilderness it contains must be maintained. Numerous other scientists have stated this as well.

The purposed forest plan falls short in protecting LLRHW cres within the Wi;derness Study Area but also fails to consider acres outside the WSA, where there exists plenty if acres deserving of protection under the Wilderness Act of 1964. which is the only standard necessary to ensure adequate protection, when also adequately enforced that not only includes the Gallatin range but the Bridger range as well.

The establishment of wildlife corriders and related infrastructure outside of critical protected areas as the plan suggests is also critical to migratory species faced with a changing climate. The focus should be on protecting the core habitat which is experiencing increased human impacts that threaten its intregrity long term.

Also, the plan excludes bison from the forest and fails to include enforceable standards for migatory bison, which unduly cpmplicates the issues bison are faced with. The politicalization of bison has for too long impeded their traditional migratory routes to needed wintering range that exists in the forest outside of Yellowstone Park.

The plan fails to make the uniqueness of the ecosystem a priority, preferring to pander to other interests who have numerous opportunities to recreate outside the ecosystem, while wildlife aren't afforded that option.

I feel the plan should be revisited with a greater appreciation for the wildlife and wilderness character of this ecosystem that makes it the centerpiece of this region.

The reasons for this objection are: Not enough area is being proposed for the Wilderness Study Area. Wildlife

are needlessly being sacrificed for more recreation areas that are not needed. Wildlife corridors are very important in helping the needless deaths of wildlife the motorized vehicles and bicycles.
