Comments: I am writing about the proposed mining operations made by Midas Gold for the Stibnite area. This company is interested in earning a profit and would not propose this project unless it was thought to be profitable. The company has invested substantially in this project and expects that investment to perform. The project will result in considerable excavation work and displacement of streams in that area. The current site is one of considerable environmental disruption and damage. I fully support Midas Gold in its proposal.

Unlike previous mining operations in the area, Midas Gold has developed a comprehensive plan of disruption mitigation and rehabilitation.
