My overall opinion of this project is this it will not benefit the local communities, and will lead to more environmental degradation within the South Fork drainage which in turn will lead to environmental issues down stream and in the surrounding area, as well as open the door for other mioning companies to operate on National Forest and public lands.

Idaho is one of the most wild states in the union, comprised of almost 75% public lands.
