Re: Grand Mesa, Uncompahgre and Gunnison Forest Plan Revision #51806

Thank you for the opportunity to provide input on the revision to the Grand Mesa, Uncompahgre, and Gunnison (GMUG) Forest Plan. We are a grassroots coalition of Coloradans who believe that our rivers are some of the most important assets on the GMUG National Forests. To date, more than 120 Coloradans who support our mission to protect our state's water resources have submitted public comments encouraging you to make all free-flowing rivers with outstandingly remarkable values eligible for Wild & Scenic protections as part of this forest plan revision.

These Coloradans have cited a variety of outstandingly remarkable values for you to consider, including the popular outdoor recreation opportunities these waters sustain, the function they serve as critical climate change refuges, their utility as vital scientific research areas, the habitat they provide for important species, the gorgeous scenery they feature, and their status as unique and irreplaceable cultural and historic resources.

As you have probably observed, many of these Coloradans referenced in their submissions their support for Wild & Scenic protections for all river, creek, and stream segments described on our coalition website at <https://ourcowaters.org/gmug/>. For the record, below are the specific eligibility determinations that our coalition believes are warranted and that our website cites:
