"This was an eye-opening teardown of the pesticide glyphosate (more commonly known as RoundUp). Within the first two or three chapters Seneff has convinced you that it is incredibly toxic stuff - and likely contributing to a large amount of chronic health conditions that have increased in prevalence over the last 30ish years. She cites hundreds of scientific papers backing this up, and then dives deep (very deep) into the biological mechanisms by which this is all happening inside our bodies.

The book gets increasingly focused on biology (and increasingly difficult for non-biologists) as you go. Starting with the big picture: how glyphosate impacts health in various animal and human studies (accessible to anyone), and then drilling into how the specific pathway it targets causes problems for us (because it exists in our microbes), and then finally getting into the depths of amino-acid substitutions, and how the shape and makeup of a particular protein can make it more susceptible to glyphosate - thus explaining how it manages to affect our bodies in all these different ways.

The book is worth reading just for the first part, and if you want to deep dive into the biology it's all there for you,

though you will likely need a strong cup of coffee and a notebook to make sense of it if you're not a biologist.

If you get overwhelmed by the science - and I did at times - I recommend skipping ahead to the last chapter where Seneff outlines what we can do with the situation we're in, and how we as individuals can improve our health with simple changes in our diets and behavior. Since reading this book I've tried much harder to eat as much organic, raw produce as is practical for our family.

I highly recommend the book and it will change your perspective on food. Just don't be surprised if you have trouble making it through the whole thing!"

EPA Finds Glyphosate Is Likely to Injure or Kill 93% of Endangered Species

WASHINGTON- The Environmental Protection Agency released a draft biological evaluation today finding that glyphosate is likely to injure or kill 93% of the plants and animals protected under the Endangered Species Act.

"The long-anticipated draft biological evaluation released by the agency's pesticide office found that 1,676 endangered species are likely to be harmed by glyphosate, the active ingredient in Roundup and the world's most-used pesticide.

The draft biological opinion also found that glyphosate adversely modifies critical habitat for 759 endangered species, or 96% of all species for which critical habitat has been designated.

"The hideous impacts of glyphosate on the nation's most endangered species are impossible to ignore now," said Lori Ann Burd, environmental health director at the Center for Biological Diversity. "Glyphosate use is so widespread that even the EPA's notoriously industry-friendly pesticide office had to conclude that there are hardly any endangered species that can manage to evade its toxic impacts."

Hundreds of millions of pounds of glyphosate are used each year in the United States, mostly in agriculture but also on lawns, gardens, landscaping, roadsides, schoolyards, national forests, rangelands, power lines and more."

"In July 2018, Dewayne Johnson (a former school groundskeeper) was diagnosed with non-Hodgkin's lymphoma. He sued Monsanto alleging the chemical glyphosate (an ingredient in Roundup) caused his cancer. Mr. Johnson used Roundup as part of his job. On August 10, 2018 a jury in San Francisco delivered a verdict in Mr. Johnson's favor. The judge ordered Monsanto to pay Mr. Johnson \$289 million in total damages."

Monsanto's Court Loss --- June 2020

"On June 24, 2020 BayerAG was ordered to pay more than \$10 billion to end tens of thousands of lawsuits filed over its Roundup weedkiller.

The settlement calls for Bayer to pay from \$8.8 billion to \$9.6 billion to resolve current Roundup lawsuits. The company will also set aside \$1.25 billion to fund payouts for potential claims in the future."

Monsanto Agrees to Plead Guilty --- December 2021

"Monsanto admitted in a plea agreement filed today that it committed 30 misdemeanor crimes related to the use of a glufosinate ammonium-based product sold under the brand name Forfeit 280. After using the product in 2020 on corn fields on Oahu, Monsanto allowed workers to enter the fields during a six-day "restricted-entry interval" (REI) after the product was applied.

The plea agreement calls for Monsanto to serve three years of probation, pay a total of \$12 million and continue for another three years a comprehensive environmental compliance program that includes third-party auditor."

It has also led to activists pushing for agencies to take a much harder look at the underlying data about the potential side effects of exposure to glyphosate, the active ingredient."

"Monsanto on Thursday asked a St. Louis judge to delay the start of a trial over claims brought by three men alleging exposure to Monsanto's glyphosate-based herbicides, such as the popular Roundup brand, caused them to develop non-Hodgkin lymphoma.

Opening statements in the case of Neal v. Monsanto are expected next week. But on Thursday morning Monsanto requested a continuance "due to exigent circumstances." The company did not detail its reasons in the filing."

"WASHINGTON, June 21 (Reuters) - The U.S. Supreme Court on Tuesday rejected Bayer AG's (BAYGn.DE) bid to dismiss legal claims by customers who contend its Roundup weedkiller causes cancer as the German company seeks to avoid potentially billions of dollars in damages.

The justices turned away a Bayer appeal and left in place a lower court decision that upheld \$25 million in damages awarded to California resident Edwin Hardeman, a Roundup user who blamed his cancer on the pharmaceutical and chemical giant's glyphosate-based weedkillers."

Monsanto Roundup Lawsuit Update, August 26, 2022

"As of May 2022, Monsanto has reached settlement agreements in nearly 100,000 Roundup lawsuits. Monsanto paid approximately \$11 billion. Bayer has accomplished this by negotiating block settlement arrangements with plaintiffs' lawyers who have large numbers of cases in the litigation.

Although these settlements account for nearly 80% of all pending Roundup claims, there are still about 26,000-30,000 active Roundup lawsuits. Most lawsuits have been filed in state court. But there are still over 4,000 claims in the MDL Roundup class action lawsuit pending in California.

New Roundup lawsuits continue to get filed regularly. Our Roundup attorneys get calls and online contact forms from Roundup victims with NHL almost every day."
