## Reviewing Officer Beum:

Crested Butte Mountain Resort (CBMR) respectfully submits this objection to the Revised Land Management Plan for the Grand Mesa, Uncompangre, and Gunnison (GMUG) National Forests and Draft Record of Decision (ROD).1

CBMR appreciates the Forest Service[rsquo]s extensive level of work, public outreach, and coordination in preparing the Revised Land Management Plan. CBMR submits this objection to preserve its standing and right to participate in any objection resolution meetings that may occur.

## I. CBMR Supports the Adoption of the Preferred Alternative

CBMR supports the adoption of the Preferred Alternative as clarified and revised by the Forest Service in the Revised Land Management Plan. CBMR participated in each stage of the GMUG forest planning process and submitted comments on the Draft Revised Land Management Plan. See Exhibit 1 (November 23, 2021 Comments by CBMR on Draft Forest Plan). CBMR appreciates the Forest Service[rsquo]s consideration of its comments on the Draft Plan and the Forest Service[rsquo]s clarifications and revisions in response to each of CBMR[rsquo]s comments. See GMUG Final EIS, Volume 3 at 113, 204.

CBMR operates a four-season ski resort on National Forest System lands within the GMUG under a long-term special use authorization. The lands within CBMR[rsquo]s special use permit boundary have been designated for developed skiing and recreation under the GMUG Forest Plan for forty years. CBMR and the Forest Service have a longstanding partnership and have worked together over the last four decades to provide high-quality public recreation on the public lands within CBMR[rsquo]s special use permit boundary.

CBMR submits this objection as the holder of a long-term authorization for the development and operation of ski area recreation facilities on the GMUG. CBMR supports the adoption of the Preferred Alternative as clarified and revised by the Forest Service in the Revised Land Management Plan. CBMR submits the objection to preserve its right to participate in any objection resolution meetings that may occur and respectfully requests that the Forest Service notify CBMR of the opportunity to participate in any objection resolution meetings.
