Subject: Stillwater Mine Complex Amendment 14 Environmental Impact Statement #296522:

Unmitigated Impacts to Schools and Homeowners

Dear Mr. Jedra and Mr. Dahlgren;

Please take into consideration the following comments and included exhibits and referenced documents in your NEPA/MEPA review of the current major amendment application (014) that extends the life of the Nye Mineral Development (00118) by up to 42 years:

1. Please complete a comprehensive cumulative analysis "hard look" at the existing and potential future Socioeconomic Impacts for Nye Mineral Development for the following reasons:

a. The previous NEPA/MEPA record does not appear to have analyzed the impacts of Transportation Stipulations for the Nye Mineral Development (e.g. forced bussing/car pooling requirement) on schools and communities in Stillwater County. This "condition of employment" may contribute to employees finding housing beyond the immediate vicinity of the mineral development.

b. The previous NEPA/MEPA record does not appear to have analyzed the impacts of Mine Sponsored Housing Restrictions for the Nye Mineral Development on schools and communities in Stillwater County. This stipulation may limit Sibanye's ability to provide additional employee housing near the mineral development. This stipulation may force employees to find housing beyond the immediate vicinity of the mineral development.

c. The previous NEPA/MEPA record appears to have used a low count of Mine Development Employees for analysis of impacts on schools and communities in Stillwater County. The previous NEPA/MEPA record contemplated a maximum of 700 Nye Mineral Development Employees (including contractors at Nye); while the actual employee numbers just at Nye have been over 1,700 employees (including contractors). (see Exhibit 5, pdf page 415 of 505)

d. Much of the past socioeconomic analysis in NEPA/MEPA and in the 1998 Nye Impact Plan is extremely outdated. Tax values, average home values (\$70,000 in the plan), school populations, and inflation are all now very inaccurate in the approved plan. (see Exhibit 5, pdf pages 34-149).

e. The previous NEPA/MEPA record does not appear to have analyzed the (1) tax base amount, (2) tax base per student, or (3) tax base type (% of industrial, commercial, residential) of individual/separate Stillwater County school districts. This is important to understanding how taxpayers and students in different school districts could be impacted and important to understanding how tax revenue disparities could be also mitigated through the Property Tax Base Sharing Act (MCA 90-6-401). (for example, see Exhibit 1).

2. Please compare the current EIS socioeconomic analysis to the assumptions and predictions of the last approved Hard Rock Mining Impact Plan (AM2 1998) for the Nye Mineral Development (see Exhibit 5, pdf pages 34-149).

3. Please carefully listen to all of the audio (public record) from both the September 24, 2021 and the November 30, 2023 Mine Impact Board Meetings. These 2 public meetings provide corroborating evidence to the validity of Park City's concerns. (see Exhibits 18 & 21)... or go to the following links to access the audio.
