My husband, Robert, and I own a cabin at 484 Brentwood Dr. , Lake Arrowhead. During the 2007 fire, we learned the firefighters had marked our home as burned.

By the grace of God, it did not burn. Only the windows got scorched. However, there was considerable devastation to the forest, our backyard. Many trees just feet from our foundation, burned. Numerous trees fell and are still on the mountain side.

We have cleared some of the debris, but the huge trees that burned and those the firefighters chopped down remain.

We had Forest Care's service last year. However, they were not authorized to remove the national forest trees.

We would enthusiastically appreciate any assistance we could receive to remove these trees. We feel they are kindling for future fires.

Unfortunately, these pictures just don't show the extent of the fire's destruction.
