The newest landmass in threat is the Tongass National Forest, currently the largest national forest in the United States. In an article by the Washington Post, President Trump has recently decreed that he will open up half of the Tongass National Forest to logging. By removing trees in the Tongass we would be harming the planet and those who rely on it for resources.

In an article by the Emerald Review it says, "Scientists refer to the Tongass as the 'lungs of the country,' . . . supported by a 2019 carbon analysis report that draws parallels between the significance of the Amazon rainforest in South America and the Tongass in North America."
