As demonstrated by the Center[rsquo]s comments submitted on the Carson Forest Plan Revision Draft

EIS in 2019, and the Center[rsquo]s objections to the Proposed Forest Plan Revision and Final EIS

earlier this month, the Center has an interest in a wide range of issues concerning forest

management addressed by the proposed plan, including but not limited to livestock grazing,

wilderness, wild and scenic rivers, fuels and vegetation management, climate change, protection

of wildlife species and habitats, recreation management, and water resources.

Each of the following objections, to which we request interested person status, raises one or

more of these issues, and implicates the Center[rsquo]s interests in management of the Carson National

Forest:

Objection of Western Watersheds Project (dated Nov. 1, 2021), which raises issues of

interest to the Center concerning the management of, and the Plan Revision FEIS[rsquo]s

analysis of, livestock grazing, and wildlife impacted by such grazing. The Center is generally supportive of this objection.

Objection of Amigos Bravos et al. (dated Nov. 1, 2021), which raises issues of interest to the Center concerning: (1) the Forest Service's analysis of Wild and Scenic River Eligibility, (2) Outstanding National Resource Waters protections and plan components; (3) water quality standards. The Center is generally supportive of this objection.

Objection of American Rivers (dated Nov. 1, 2021), which raises issues of interest to the Center concerning the Forest Service's analysis of Wild and Scenic River Eligibility. The Center is generally supportive of this objection.

Objection of NM Chapter of Backcountry Hunters and Anglers (dated Oct. 31, 2021) which raises issues of interest to the Center concerning the impacts of livestock grazing on wildlife. The Center is generally supportive of this objection.

Objection of Rio Arriba County (dated Oct. 30, 2021), which raises issues of interest to the Center concerning the management of, and the Plan Revision FEIS's analysis of, livestock grazing, valid existing rights, historic and cultural uses of the area, and the use of the best available science. The Center has questions about this objection.
