FOREST ORDER

USDA FOREST SERVICE

Medicine Bow National Forest

Laramie, Brush Creek-Hayden and Douglas Ranger Districts

Winter Travel Management and Occupancy and Use

Pursuant to 16 United States Code (U.S.C.) § 551 and 36 Code of Federal Regulations (C.F.R.) § 261.50 (a) and (b), the following acts are prohibited on all National Forest System Lands located on the Medicine Bow National Forest, State of Wyoming, (the "Restricted Area") and on all roads and trails located within the Restricted Area (the "Restricted Roads and Trails"):

The purpose of the Order is to provide for public safety, resource protection and reduce user conflicts on the Forest.

PROHIBITIONS:

- 1) Using any wheeled motor vehicle from December 15th-April 15th of each year on those designated and/or groomed snowmobile trails as indicated on the current State Trails map for the Medicine Bow National Forest. . 36 C.F.R. § 261.55 (b)
- 2) Operating or using any over the snow vehicle (OSV) off of designated routes shown on the local Forest Service Motor Vehicle Use Map between June 1st and November 15th. 36 C.F.R. § 261.56
- 3) Operating an OSV off of designated routes shown on the local Forest Service Motor Vehicle Use Map where snow depths are less than approximately 12 inches, or when/where snow cover conditions are insufficient to protect soil and vegetation resources. 36 C.F.R. §.261.56


EXEMPTIONS:

Pursuant to 36 C.F.R. § 261.50(e), the following persons are exempt from this order.

1. Any person with a permit specifically authorizing the otherwise prohibited act or omission.
2. Any Federal, state or local officer, or member of an organized rescue or firefighting force in the performance of an official duty.

This Order will become effective October 1, 2013 and shall remain in effect until rescinded or until October 1, 2018 whichever event occurs first.

Violations of any prohibition are punishable by a fine of not more than \$5000 for an individual or \$10,000 for an organization, or imprisonment for not more than 6 months or both. 16 USC 551 and 18 USC 3559 and 3571.

ORDER DEFINITIONS:

"Wheeled Motor Vehicle" Any vehicle that is self-propelled and does not utilize sled runners or skis and an endless belt tread and has any type of wheel on it.

"Over Snow Vehicle" Any motor vehicle which utilizes sled runners, ski's or tracks and an endless belt tread designed for over the snow operation.
