## 4. FIRST AID MEASURES

Rinse mouth with water. If swallowed, give a glass of water to drink. If vomiting occurs give further water. Seek medical advice.

#### Indication of immediate medical attention and special treatment needed:

Treat symptomatically. Following cases of gross overexposure, investigation of liver, kidney and eye function may be advisable. Records of such incidents should be maintained for future reference. No known specific antidote.

### 5. FIRE FIGHTING MEASURES

### Specific hazards arising from the chemical:

Combustible liquid. Vapour may travel a considerable distance to source of ignition and flash back.

### Special protective equipment and precautions for fire-fighters:

On burning will emit toxic fumes, including those of oxides of carbon . Fire fighters to wear self-contained breathing apparatus and suitable protective clothing if risk of exposure to vapour or products of combustion. Keep containers cool with water spray.

### 6. ACCIDENTAL RELEASE MEASURES

### **Emergency procedures/Environmental precautions:**

Shut off all possible sources of ignition. Clear area of all unprotected personnel. If contamination of sewers or waterways has occurred advise local emergency services.

#### Personal precautions/Protective equipment/Methods and materials for containment and cleaning up:

Slippery when spilt. Avoid accidents, clean up immediately. Wear protective equipment to prevent skin and eye contact and breathing in vapours. Work up wind or increase ventilation. Contain - prevent run off into drains and waterways. Use absorbent (soil, sand or other inert material), Collect and seal in properly labelled containers or drums for disposal. Wash area down with excess water.

### 7. HANDLING AND STORAGE

Classified as a C2 (COMBUSTIBLE LIQUID) for the purpose of storage and handling, in accordance with the requirements of AS 1940. Refer to State Regulations for storage and transport requirements.

### Precautions for safe handling:

Avoid skin and eye contact and breathing in vapour. Vapour may travel a considerable distance to source of ignition and flash back. Take precautionary measures against static discharges.

#### Conditions for safe storage, including any incompatibilities:

Store in a cool, dry, well ventilated place. Store away from sources of heat or ignition. Avoid temperatures >40°C. Protect from moisture. Nitrogen blanket recommended for large tanks (capacity 100m3 or higher). Exposure to nitrogen may cause asphyxiation or death. Personnel must observe strict safety precautions when involved with a confined space entry. Store away from incompatible materials described in Section 10. Keep containers closed when not in use - check regularly for leaks.

### 8. EXPOSURE CONTROLS/PERSONAL PROTECTION

Propane-1,2-diol (propylene glycol) (total: vapour & particulates): 8hr TWA = 474 mg/m $^3$  (150 ppm); (particulates only): 8hr TWA = 10 mg/m $^3$

TWA - The time-weighted average airborne concentration of a particular substance when calculated over an eight-hour working day, for a five-day working week.

#### Appropriate engineering controls:
