Please find additional comments for your consideration of Coeur Alaska's Plan of Operations Amendment 1 (POA 1) which proposes to continue and expand the production of the Kensington Mine.

COVID-19 has impacted most local businesses, especially those reliant upon the tourism industry. We have been fortunate enough to maintain our daily operations due to our diversification in the industries we service. The Kensington Mine has been an especially important customer during this time, and has been a reliable, and trustworthy business partner from the beginning of the mine's operation in 2010.

Our relationship began with being the primary supplier of rental equipment and construction supplies for the development of the mine. This included having employees at site for surface support from the mine's commencement. Currently, we have expanded upon this relationship with sales and support of underground mining equipment. The expansion of our services provided the opportunity to construct a new eight-bay shop and parts warehouse. Design and construction of these new facilities were completed in partnership with local designers and contractors.


Underground mining equipment requires re-building of major components after extensive use, a function that previously was completed by sending the equipment down to the manufacturer's shop in Nevada. With the completion of our eight-bay shop, we are now able to provide this as a service performed in Juneau with local labor.

Tyler Rental currently has 26 full-time and 4 part-time employees. Seven full-time employees are in positions dedicated to direct support of the mine, with a payroll of approximately \$1 million. All of our employees are Juneau residents, many of whom have school age children.

Through supporting the local economy by employment, paying taxes, etc. Kensington Mine provides indirect support to the other facets of our business that are geared towards government services, commercial contractors, and local homeowners. In-turn, this support allows us to maintain our full-time employment of Juneau residents.

Further development at Kensington Mine will be beneficial to not only Tyler Rental, but other local businesses as well. Thank you for the opportunity to comment in support of such a pivotal contributor to our local community.
