# 4. FIRST AID MEASURES

For advice, contact a Poisons Information Centre (e.g. phone Australia 131 126; New Zealand 0800 764 766) or a doctor.

### Inhalation:

Remove victim from area of exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. For all but the most minor symptoms arrange for patient to be seen by a doctor as soon as possible, either on site or at the nearest hospital.

#### **Skin Contact:**

If spilt on large areas of skin or hair, immediately drench with running water and remove clothing. Continue to wash skin and hair with plenty of water (and soap if material is insoluble) until advised to stop by the Poisons Information Centre or a doctor.

### **Eye Contact:**

Immediately wash in and around the eye area with large amounts of water for at least 15 minutes. Eyelids to be held apart. Remove clothing if contaminated and wash skin. Urgently seek medical assistance. Transport promptly to hospital or medical centre.

#### Ingestion:

Immediately rinse mouth with water. If swallowed, do NOT induce vomiting. Give a glass of water. Seek immediate medical assistance.

## 5. FIRE FIGHTING MEASURES

### **Suitable Extinguishing Media:**

Not combustible, however, if material is involved in a fire use: Fine water spray, normal foam, dry agent (carbon dioxide, dry chemical powder).

Hazchem or Emergency Action Code: 2X

### Specific hazards arising from the chemical:

Non-combustible material. Decomposes on heating emitting toxic fumes including those of oxides of sulfur.

### Special protective equipment and precautions for fire-fighters:

Decomposes on heating emitting toxic fumes. If safe to do so, remove containers from path of fire. Fire fighters to wear self-contained breathing apparatus and suitable protective clothing if risk of exposure to products of decomposition.

# 6. ACCIDENTAL RELEASE MEASURES

## **Emergency procedures/Environmental precautions:**

Clear area of all unprotected personnel. Wear protective equipment to prevent skin and eye contact. Avoid breathing in vapours. Work up wind or increase ventilation. If contamination of sewers or waterways has occurred advise local emergency services.

## Personal precautions/Protective equipment/Methods and materials for containment and cleaning up:

Contain - prevent run off into drains and waterways. Use absorbent (soil, sand or other inert material). Collect and seal in properly labelled containers or drums for disposal. Neutralise residues with lime or soda ash. Wash area down with excess water.

## 7. HANDLING AND STORAGE

This material is a Scheduled Poison S6 and must be stored, maintained and used in accordance with the relevant regulations.

## Precautions for safe handling:

Avoid skin and eye contact and breathing in vapour, mists and aerosols. Keep out of reach of children.

#### Conditions for safe storage, including any incompatibilities:

Store in a cool, dry, well ventilated place. Do not allow to freeze. Store in stainless steel, plastic or epoxy lined vessels. Store away from incompatible materials described in Section 10. Do not store in aluminium containers. Do not store in copper or copper alloy containers. Do not store in mild steel containers. Store away from foodstuffs. Keep containers closed when not in use - check regularly for leaks.

# 11. TOXICOLOGICAL INFORMATION

**Ingestion:** Swallowing can result in nausea, vomiting, diarrhoea, abdominal pain and

chemical burns to the gastrointestinal tract.

**Eye contact:** A severe eye irritant. Corrosive to eyes; contact can cause corneal burns.

Contamination of eyes can result in permanent injury.

**Skin contact:** Contact with skin will result in severe irritation. Corrosive to skin - may cause skin

burns.

**Inhalation:** Breathing in mists or aerosols may produce respiratory irritation.

**Chronic effects:** No information available for the product. For the component Sulfuric acid: Repeated overexposure may lead to chronic conjunctivitus, lung damage and dental erosion. The International Agency for Research on Cancer (IARC) have concluded that occupational exposure to strong inorganic acid mists containing sulfuric acid is carcinogenic to humans, causing cancer of the larynx and to a lesser extent, the lung. No direct link has been established with sulfuric acid, itself, and cancer in humans. Exposure to any mist or aerosol during the use of this product should be avoided and exposure should not exceed the exposure standard.
