Would it be possible to find out who in the USFS developed the Air Resource related information for the GMUG Draft Assessment (https://www.fs.usda.gov/project/?project=51806)? I have several comments for the Air Resource Assessment that I plan to submit, and a few of them are suggesting that the USFS use information from the Colorado Air Resource Management Modeling Study (CARMMS) 2.5 Report that was developed in conjunction with the USFS (USFS paid for the additional work for CARMMS version 2.5) where we modeled Regional air quality impacts for year 2025 and what the contribution to that cumulative year 2025 air quality could be for each Colorado-based Forest including GMUG. The current Air Quality write-up for the Draft GMUG Assessment takes into consideration CARMMS 2.0 but not CARMMS 2.5 that was developed specifically for the USFS. I would like to get a copy of the CARMMS 2.5 Report and related products to someone in the USFS that is developing the Air Quality assessments for Forests located in Colorado.
