The cost of living is so high here and with little to no access to fresh food(and the price of the "fresh" we get is extremely high) we are forced to gather food for ourselves if we want to provide for our families economically. This is also a form of recreation we do as a family together and no one has the right to take that away. My 5 year old son goes with us on the boat to pull shrimp pots every summer, and helps reel in the Silvers every fall. It would be devastating to take those opportunities away from us. These trips also provide for our neighbors and friends who aren't as fortunate as us, on days we are extra successful and within our bag limits, we share with our members of our communities. Our neighbors who have 5 kids always get a package of halibut when we come back from fishing, or shrimp, or deer roast. My coworkers enjoy the roasts, fillets, burgers I bring into work to share with them.

The same goes for the Chugach National Forest, the existing regulations aren't broken or wrong there is no need to change them. Motorized access provides multiple recreation opportunities for people around the state that helps fuel the local economy. There are great annual events in these areas that draw people from all over the state. This provides a much needed boost in the slow winter months for many small business connected to these areas. This is another area my Family has enjoyed for generations, and will continue to enjoy for multiple generations as Alaskans in the Future. I have multiple friends and family who use motorized vehicles to access winter ice fishing lakes, or ptarmigan and grouse hunting grounds in the winter. And we co exist just fine with the non motorized winter enthusiasts also.
