However, the link is bad and nothing shows up in the screen, and the pdf download has an error message: "Acrobat could not open '110188_FSPLT3_4499574.pdf' because it is either not a supported file type or because the file has been damaged (for example, it was sent as an email attachment and wasn't correctly decoded). To create an Adobe PDF document, go to the source application. Then print the document to Adobe PDF."

I had asked for that document on October 24th, then it was not posted in a timely manner so I asked again on November 29th, now ten days before the scoping deadline there is a document that the public wasn't notified about and is unreadable on your website.
