RESTRICTING MOTORIZED VEHICLES FROM ANY AREAS DOES NOT ACCOMPLISH ANY REAL GOALS OF VALUE. NO REAL DAMAGE TO THE ENVIRONMENT OR WILDLIFE OCCUR DUE TO MOTORIZED VEHICLES IN OUR WILDERNESS AREAS. SUCH RESTRICTIONS SIMPLY PLACATE THOSE THAT WISH TO RESTRICT OTHERS ACTIVITIES. THESE GRUMPY PEOPLE ARE THE SAME ONE'S THAT WILL DRIVE 10 MPH FOR 3 MILES ON A GRAVEL ROAD, RATHER THAN GETTING OVER, AND LETTING SOMEONE PASS THAT IS COMFORTABLE DRIVING SAFELY AT 25 MPH.
