Dear Ranger Garten and Project Leader Williams;

We appreciate you and your staff meeting with us recently to discuss your up-coming Ewing Mountain Vegetation Project and we appreciate the opportunity to be involved in your forest management plan decisions.

The Mount Rogers NRA Trail Advocates' Coalition understands the need to maintain our National Forest and wish to work in concert with you to ensure the forest remains healthy so that we all can continue to enjoy the beauty it provides. After studying your May 16th proposed project plan we have the following comments and questions to submit for your consideration:

\* Project Location: outline

More information needed before comment:

Many of the targeted harvest areas (units) are adjacent to or are in the immediate vicinity of popular horse trails. How many units will be harvested simultaneously? Does your Vegetation Project allow for a scenic buffer of some distance between the trails and the harvesting area? Assuming you will be using existing historic logging roads during the harvesting, will those logging roads be left accessible afterwards since those historic roads are currently being used by trail riders? Your May 16th letter indicates management actions will be planned over the next 1 to 5 year; will harvesting be conducted during this time? Has thought been given to state road conditions and the impact of logging trucks on same? Have you considered the impact of your project on the local economy?
