WE HAVE NEVER BEEN DISRUPTED WHILE HUNTING BY ANOTHER HUNTER RETRIEVING GAME WITH A MOTOR VEHICLE NOR HAVE WE DISRUPTED ANOTHER HUNTER WHILE RETRIEVING GAME OURSELVES. REGULATION THAT PROHIBITS USING A MOTOR VEHICLE TO RETRIEVE DEER WILL MAKE CRIMINALS OUT OF GOOD PEOPLE.

THE RDEIS STATES ONLY 3.5% OF FOREST VISITORS BELIEVE DISPERSED CAMPSITE LOCATIONS ARE A MAJOR CONCERN.
