Comments: Permit Fees

We have seen a ranger every single time we hike the Santiam Lake area and he told us he was sent there to count people and he had not seen a single person in 2 days. I have hiked Jefferson Park many times, not crowded on weekdays, although I agreed with the overnight camping permit requirement. I have hiked Tenas Lakes area && Scott Mountain, see very few people on weekdays. And Waldo Lake? What a joke! Very few hikers there ever. There are a lot of campers in the summer that pay to camp in the campground, but very few hikers. As for fees. you need to keep it extremely low, as low as possible.
