I live in this region for the bountiful salmon runs, the beautiful scenery, the clean air and water, and the endless opportunities to recreate in our expansive outdoors. I am one of the 94% of Southeast Alaskans that eats salmon every year. The freshwater streams where salmon and old growth forest of the Tongass provide spawning habitat for these fish, which in turn feed a matrix of bears, birds, insects, and other wildlife that Alaska is so famous for. The health of our economy, which is heavily dependent on the fishing and tourism industries, also depends on the salmon, wildlife and presence of old growth forests. A sustainable future for Southeast Alaska requires protecting expansive areas of intact habitat - in short, it requires keeping our Roadless areas roadless! I urge the Forest Service and the Secretary to protect important salmon spawning habitat, maintain old growth forests for winter deer habitat, and keep the places I like to recreate free of clearcuts and roadbuilding.
