Thank you for your interest in the Oil and Gas Leasing Availability Analysis on the National Forests and
Grasslands in Texas. I have noted your objection to fracking.

I would very much appreciate the opportunity to visit with you about this project. In fact, I'm hoping to
receive an invitation to address the Lake Conroe Association. In the meantime, I'll share a few
thoughts:

* The purpose of the project is two-fold:

- o Identify lands managed by the National Forests and Grasslands in Texas that may be
available for lease; and
- o Determine the conditions/stipulations under which the land may be leased.

* The decision will not authorize the lease of a single acre. Similarly, the decision will not
authorize any surface (or water) disturbing activity. It will not authorize exploration,
development of well pads or drilling of any kind (including hydraulic fracturing).
