Comments: Lutsen Mountains Ski Area Expansion Project

Dear Supervisor Constance Cummins,

I appreciate the opportunity to submit scoping comments regarding the Lutsen Mountains Ski Area Expansion Project.

Before getting to my project-specific comments, I first want to express my disappointment that you are holding a 30-day comment period in the midst of the COVID-19 pandemic. The COVID-19 pandemic has made it extremely difficult for myself and many other people, including those without broadband internet access, to review and comment on the Notice of Availability and Proposed Action. This is a major development proposal and to move forward without any public meetings or opportunities for the public to engage directly with the Forest Service and Lutsen Mountains Corporation (LMC) is unacceptable. The Superior National Forest should extend this comment period until after the pandemic has subsided and everyone is able to provide informed comments.

The Superior National Forest should not grant LMC a Special Use Permit to expand onto Forest Service land.

The proposed Lutsen Mountains Ski Area Expansion Project threatens the future of backcountry skiing opportunities on the North Shore. Moose Mountain holds the most unbroken ski-able vertical feet in Northern Minnesota and is a valuable resource for backcountry skiers. Vertical feet of skiable pitch is a finite resource in our region, and needs to be shared. Given that half of Moose is already owned by LMC, the public lands on Moose Mountain should be left for everybody else to enjoy.

Rather than granting LMC a Special Use Permit, the Superior National Forest should consider the development of a backcountry ski area on Moose Mountain. I support Superior Highland Backcountry's vision for a Backcountry Ski Area on Moose Mountain and believe this would be a better use of these public lands. An expansion of the same old type of ski area is likely not going to bring any new visitors to our region. No matter how much Lutsen expands, the fact remains that there is only 700' of vertical terrain. While this is impressive for Minnesota, it can't compete with the draw of Western resorts for the destination skier. However, diversifying the variety of winter sports available in northern Minnesota will draw new visitors. Backcountry skiing is the fastest-growing segment of the ski industry, and adding a backcountry ski area to the mix of winter opportunities already available in Lutsen will entice more people to visit the area and strengthen the economy.

The Environmental Impact Statement for this project should include an alternative that analyzes a backcountry ski area, as proposed by Superior Highland Backcountry.

As a regular season pass holder who travels from the Minneapolis area twice a month during the winter season, I would rather see LMC improve on the exiting resort area. There are many things they could do to make this a more desirable ski destination. Upgrade to a high speed lift on the bridge chair, which services one of there longest runs. They could have all there lifts and runs open when they are stating that the resort is "fully open". We have been there many times and are not able to access the "full" resort. You pay "full" price for a lift ticket but are not able to use the whole resort.

They could also add a new lift on moose mountain closer to the chalet side (by Bull Run).

There is plenty of area on Mystery Mountain which they could use to put additional runs in and they could add a

high speed lift in place of that old uncomfortable lift they currently have.

They could improve on there grooming of runs. Trollhaugen, a small ski resort in Wisconsin does a much better job of keeping their trails groomed.

They could put lights on some runs and offer night skiing.

All in all, we choose to not spend the money to go to an overpriced, overcrowded resort out west and feel that the atmosphere on the north shore gives skiing a better experience. We would like to keep putting our money into our own economy.
